At the end of the day I will wish to have a period of about half-an-hour in which to review my notes of the day, following which I will be pleased to give informal feedback. I hope that as many members of the project team as possible can attend that feedback session.

Following the visit a report will be sent to EACEA. The EACEA will write formally to the project coordinator to summarise the outcomes with request to share and discuss them with you. The consortium will thus have an opportunity to comment on it.

I am very much looking forward to the visit and to learning more about your interesting project. If there are any documents (such as project meeting minutes, papers, outputs) which you feel will be helpful for me to see in advance of the meeting and if you would like to prepare a brief self-evaluation of the state of the project, I would really appreciate this.

I attach to this letter the broad headings which I will wish to discuss during my visit. If there are additional topics which you wish to discuss, please let me know.

I look forward to meeting you on October 9, 2014.
